## THE CONCORDIA SPREADING YOUR WINGS GRANT

The Concordia Spreading Your Wings Grant is designed to support and encourage participants and graduates of the Let's Start Up Pathway who have started their own business. A **\$5,000 grant** will be awarded to the recipient to help her give wings to her business.

### ELIGIBILITY CRITERIA

- Be a woman 18 years of age or older
- Be a graduate or a participant of the Entrepreneurship Program within the Let's Start Up Pathway
- The business must have started its first sales at least one year ago
- The head office of the business must be located in Canada
- Attend the information session as well as a virtual meeting with our coaches
- Be present at the annual graduation at Concordia University on September 17th, 2026

### REQUIRED DOCUMENTS

- Registration form
- Your business plan and financial forecast
- A video presentation (max. 3 min)

The application period is from **Friday, May 1st to Wednesday July 15th, 2026**

<b>ENTREPRENEUR PROFILE</b>	<b>10%</b>
<ul style="list-style-type: none"> <li>• The project's entrepreneur has characteristics, attitudes and values compatible with entrepreneurship.</li> <li>• The project team (promoters, employees, suppliers, etc.) has the necessary potential.</li> </ul>	
<b>BUSINESS PLAN</b>	<b>15%</b>
<ul style="list-style-type: none"> <li>• The mission, vision, values and articulation of the project are inspiring.</li> <li>• The entrepreneur ensures a complete and clear description of her product/service.</li> <li>• The target market is clearly defined.</li> <li>• A marketing strategy is put in place.</li> <li>• The product/service realization capacity is compatible with the estimated sales/revenue volume.</li> </ul>	
<b>USEFULNESS OF THE GRANT</b>	<b>15%</b>

<b>FINANCIAL AUTONOMY</b>	<b>15%</b>
<ul style="list-style-type: none"> <li>• The project is promising in terms of achieving financial autonomy for the entrepreneur</li> <li>• The financial forecasts are realistic and demonstrate viability, even profitability.</li> </ul>

## SELECTION OF THE RECIPIENT

The selection committee, composed of Concordia University and Lise Watier Foundation members, will meet in September. The committee reserves the right to request an individual meeting with the finalists. If so, finalists will be contacted in advance and a meeting will be scheduled.

The recipient will be contacted, and the official announcement will be made on September 17, 2026, between 3:00 p.m. and 7:00 p.m., during the annual graduation ceremony for participants in the Let's Start Up Pathway at Concordia University.

## COMMITMENT OF THE RECIPIENT

The recipient agrees to give a testimonial at the grant award ceremony on **September 17, 2026, between 3:00 p.m. and 7:00 p.m.**, during the graduation ceremony for the 2025–2026 cohort of the Let's Start Up Pathway.

The recipient also agrees to collaborate with the Lise Watier Foundation in the production of textual, visual and/or video content to share her entrepreneurial experience. She agrees to complete and sign the Broadcast Consent Form, authorizing the Foundation to broadcast any image or video of her on the Lise Watier Foundation website, on other official websites and on social networks, as well as for media purposes, including promotional presentations and advertising campaigns.

## THE BUSINESS PLAN

### INDICATIONS

Make sure your business plan meets all the evaluation criteria and clearly demonstrate this, as the evaluation of applications is based on the business plan.

The business plan should clearly:

- Describe your business and its mission
- Describe your product or service
- Demonstrate a market analysis
- Describe your positioning and marketing strategies
- Describe your operations plan
- Present your financial plan

Please update your business plan if necessary to reflect the actual situation of your project. Please also describe your current sales figures.

## THE VIDEO PRESENTATION

### INDICATIONS

Introduce yourself in a short video of **no more than 3 minutes** and tell us how this grant could help you. To do so, answer these two questions:

- Why do you think you are the right person to receive the Concordia-Lise Watier Spreading Your Wings Grant?
- How would you give wings to your business?

### EXCLUSIONS

The scholarship cannot be used to:

- Pay existing debts
- Ensure your working capital
- Finance a self-promotion or communication campaign

- From your computer, collect your files in a folder (business plan and video)
- Name the folder with your name and the name of your company (ex. MaryseBenoît-ServicesCompta)
- Go to [wetransfer.com](http://wetransfer.com)
- Click on the grey link "Or select a folder "
- Select the folder you just created and click on "Import"
- Click on the blue "Get a link" button
- Once the link is generated, copy the link and paste it into your email to [mboyer@fondationlisewatier.com](mailto:mboyer@fondationlisewatier.com).
